






The County Surveyor's Committee has began voluntarily on an ambitious program to implement remonumentation programs in many counties.

 - "The real purpose of the corner retracement workshop, however, was to lend direction, to stimulate thought, to start discussion and to encourage study about proper corner retracement procedures."






1975 PUBLIC LAND SURVEY REPORT

The following report of the status of public land survey monuments in Minnesota was accomplished by the filling out of a questionnaire sent out by the MLSA Committee on Remonumentation to county surveyors or county engineers where there was no county surveyor. Other MLSA members filled in the remaining gaps. The information in this report is based on the data supplied by these volunteers and is general in nature. A more exact and detailed study would require time and funding beyond the means of the committee.

The actual survey work will be done by the County, but a State Survey Authority is necessary to oversee the counties' programs to assure good standards of performance.







> is still waiting for the House of Representatives research report. MLSA Board of Directors would like the bill to be pursued for the 1979 Legislature but support is needed.





LET'S BUILD A FIRE



About five years ago, M.L.S.A. began work on a Remonumentation Bill to serve the need for preservation and re-establishment of the Public Land Survey. A great deal of work was done by many M.L.S.A. members and supporters and a Remonumentation Bill was ultimately presented to the House and Senate. A reasonable plan for funding was included in the Bill through the State Deed Tax.

Problems encountered along the way were the large sums of money involved in a state-wide program; political science undergraduates on a legislature's staff whose answer to most problems was a two year trial program with a \$5,000 budget; and the education of the legislators as to this Bill and motivating those legislators to implement the Bill.

Let us present the case for the Bill and how it would reduce the costs of future surveys and preserve a resource of the State to the citizens I propose quarter page themselves. ads in the official county newspapers where remonumentation is needed with follow-up information monthly or every other month. Let us show the citizens the problem; how it costs them to have that problem, and what can be done about it. Give them the names and telephone numbers of their County Commissioners and their State Legislators.

Let's build a fire for the citizens of this state and let them apply some heat to their elected officials.



In my letter in the May issue of Dis-Closures, I made mention of submitting a proposal for a research project on remonumentation the to Legislative Commission on Minnesota Resources. The proposal was submitted and hearings attended to attempt to secure funding of a research pro-Because there were many more iect. requests for funding than could be covered by the funds available, our request was rejected for funding in this biennium. I am suggesting that we stay in contact with the LCMR and attempt to gain reconsideration of this effort two years from now and hopefully get a project funded.

> Jim next reported that at the request of the Legislative Commission on Minnesota Resources, he, Dickman Knutson and Tom Taylor testified at a hearing for approval of a grant for a pilot re-monumentation project. The proposal was not granted, Jim felt, due to confusion as to the intended goals.



A MODEST PROPOSAL by R. P. MURPHY, L.S.

The remonumentation program put forward by MLSA has struck a firm, five year snag: the state legislature. Those long hours we spent gathering data and making presentations seem somehow lost today. Our efforts to have the state fund maintenance of the public land survey system it delegated to the individual counties has been rejected by the legislature where it hasn't just been ignored.

What we've done so far isn't working; what more can we do? Let's strike. LET'S WHAT??? Put the tranquilizers back in your desk. There's strikes and strikes.

Why can't we organize a half day sometime when the legislature is in session where registered land surveyors from all over Minnesota come down to the capitol and demonstrate for

remonumentation on the capitol grounds. If just the registered surveyors demonstrate, there is no terrible economic burden on the firms, expecially if its just for a day. The demonstration would be brought to the intention of the press, and we could have signs stating what area the surveyor is from and who his legislators are, calling attention to the lack of help the legislature has of-One hundred land surveyors fered. with theodolites, transits and EDM's set up around the capitol would be an impressive sight indeed.

If we could clearly show the waste and expense caused by the lack of monumentation in the state, we could further our cause and put pressure on the legislature to provide some funding for this program.

A New Organization Called "MACS"

The County Surveyors in Minnesota are now organized and have formed the Minnesota Association of County Surveyors called 'MACS' as of June 24, 1983. The purposes and goals of this Association are a part of the Constitution and By-Laws and are as follows:

PURPOSES AND GOALS 1. To promote public awareness of the County Surveyor's Office and the public land survey-system.

- 2. To promote uniformity in keeping records current of all surveys, plats, and field notes.
- To promote a County Surveyor's office in every Minnesota County, either elected or appointed.
- To provide standards for remonumentation and maintenance of the Public Land

Survey Systems in order to protect and preserve the property rights of the public.

- To provide the citizens of the counties a source of advice on surveying and mapping.
- 6. To keep County Surveyors abreast of pending legislation affecting surveyors and to propose legislation if necessary.
- 7. To promote a medium for the exchange of information between County Surveyor's offices.
- To promote effective operation of the County Surveyor's offices.
- 9. To keep abreast of the developments in a cadastral system.

One of the primary goals as I see it, would be to help promote Statewide Remonumentation through the Remonumentation bill as it was re-introduced in the State Legislature in March 1983 by State Representative Virgil Johnson, Caledonia, Houston County. Virgil Johnson was a County Commissioner for many years before being elected as a State Representative in 1982. He liked and supported the original bill while a County Commissioner and felt that the State, in the rural areas especially, needed this bill to commence remonumentation

programs. In prior years, while MLSA promoted and pushed for passage of the remonumentation bill, surveyors were accused of special interests and this made support of the bill difficult. MACS as a group of County officials seeking what is best for the counties they represent should not be faced with this type of accusation and can therefore promote and support the bill which we plan to do.



Working with Stakeholders to Update and Align Boundary Data in Minnesota

Project Summary

Overview

MnGeo is leading an effort to define a stakeholder-supported process with the intent to update and align Minnesota's statewide geospatial boundary datasets, informed by authoritative data. These statewide datasets include the foundational Public Land Survey System (PLSS) boundaries and other data layers, many with boundaries concurrent with the PLSS. Aside from the City, Township and Unorganized Territory (CTU) dataset maintained by MnDOT, no state entity has the responsibility to develop or maintain statewide boundary data. Consequently, existing data layers were developed at different times, by different agencies, for different purposes, and with differences in resolution, and accuracy. As a result, other government and tribal entities are

developing improved data to more accurately represent an area of interest or project. MinGeo recognizes an opportunity to partner with authoritative data producers on a process to continuously acquire and integrate more current, accurate and authoritative data into the body of statewide boundary layers.

- A couple surveyors volunteer to be on the Geospatial Advisory Council (GAC) to ensure that surveyors voices are heard when it comes to alignment of the PLSS.
- PLSS cannot be "aligned" to other data
- Other data is adjusted and aligned to the PLSS

- 2019 MACS applies to the LCCMR to complete a pilot remonumentation project
 - Received support from the GAC
 - Part of LCCMR justification was that it would improve foundational geospatial data

- I. PROJECT STATEMENT: The Minnesota Association of County Surveyors (MACS) has compiled the number of Public Land Survey (PLS) corners and the number of certified PLS corners in each county. Minnesota has over 300,000 corners in the state and less than half of them have been remonumented and certified. Many of those certified corners do not have GPS coordinates. MACS goal is to reset all these corners and certify them with GPS coordinates for a state wide PLS layer. This proposal is for a Pilot Project. Grant County and the MACS PLS Committee are working on a pilot project in Grant County to remonument an entire township. There are 137 PLS Corners in Lawrence Township (T130N R44W) which is in the NW corner of Grant County.

- Every year, the GAC goes through process to prioritize projects
 - Solicit input from geospatial community and identify who/how to get it done
- In 2017 "Updated and aligned boundary data" was not on the list
- In 2018 "Updated and aligned boundary data" was number 8 of 14
- In 2019, 2020 "Updated and aligned boundary data" was number 2 of 14
- In 2021, 2022 "Updated and aligned boundary data" was 2 of 15
- In 2021,2022 "Remonumentation of all section corners in the State" is number 13/15

- Updated and aligned boundary data REQUIRES accurate geodetic location of section corners
- Surveyors on the GAC have been advocating updates to the PLSS will support foundational geospatial data
- Parcel and Land Records Committee on the GAC is identified as the best fit for trying to push these initiative forward
- Surveyors on the GAC serve on this committee and start to develop a legislative proposal

- Remonumentation Subcommittee 1st meeting October 4, 2021
 - Started research on how other states have enabled remonumentation legislation
 - 12 States had program
 - Reviewed numerous states program and decided to mirror Michigan
 - Statutes clearly laid out governance
 - Created commission to oversee fund and grant program
 - Counties required to submit a County Plan for remonumentation
 - Initial goal was to have legislation ready for 2023-2024 Biennium

- Identified PLSS stakeholders and build a website

The original Public Land Survey in Minnesota was completed in the early 1900's. After that time, the maintenance of the system was left to local landowners and governmental units. Unfortunately, many of the monuments were quickly destroyed.

A statewide restoration and preservation program of the PLSS will benefit every Minnesotan.

- Decided to develop proposed legislation for 2022 session
 - Wanted to set a deadline to keep momentum
 - Projected surplus
 - Realized it would be a multiyear effort, so why not start now?

- Finalized proposed legislation
 - Created a commission to oversee a grant program coordinated by MnGEO
 - Grant would be given to counties based on criteria including:
 - County Plan for remonumentation
 - Corner certificates with geodetic positions to be recorded/filed
 - Monument maintenance plan
 - Oversight by a County Surveyor or other Licensed Surveyor appointed by the County Board
 - Voluntary
 - Funded through the general fund at \$10 million per year

- Submitted to Senator Ann Johnson Stewart
 - Senator Stewart is an engineer and former teacher at UMN
 - Sees the need for surveyors and the importance of remonumentation
- She submitted the proposed legislation to the Revisor and the fun begins!

- Revisor says "Why so complicated? Make it a simple grant program."
 - Easier to digest and understand
 - Legislators are reluctant to start new commissions
- Presented to committee and decided to go this route
 - Modified to ensure:
 - Participation of the GAC
 - MN Licensed Surveyors must be involved in the grant program development
 - Remonumentation in accordance with MN Statute 381.12

- Senator Johnson Stewart introduces the bill On March 16 (SF 4037)
 - Referred to State Government Finance and Policy and Elections Committee
 - Senator Bakk added as author on March 23
 - Remonumentation Committee starts push to get supporters to contact their legislators
- Representative Anderson introduces the bill On March 21 (HF 4037)
 - Referred to State Government Finance and Elections Committee

• Important Dates:

- March 25: Committees to act favorably on bills in the house of origin
- April 1: Committees to act favorably on bills, or companions of bills, that met the first deadline in the other house.
- So we have 1 week to get this heard to keep it moving
 - Its pretty late in the session, so chances are slim

- House committee scheduled the bill for a hearing on April 1
 - So you're saying there's a chance!
- 7:00 AM March 28, Remonumentation Committee starts to line up people to testify
- By 11:30 AM the bill is pulled from the agenda

- So what happened?
- House Committee chair was informed that Senate would not hear the bill
- Senator Kiffmeyer (Chair of Senate Committee) liked the bill, but thought it was too big to fund this year. Thought odds of funding next year would be improved if a commission was created to address/advise on the problem of restoring the PLSS Monuments. Is willing to add commission to the omnibus bill.
 - So back to the drawing board

• As of April 27, 2022, this is the language in the senate omnibus bill SF 3975. Similar language in HF 4831

Sec. 56. PUBLIC LAND SURVEY MONUMENT RESTORATION.

The chief geospatial information officer must submit a report by January 1, 2023, to the chairs and ranking minority members of the committees in the house of representatives and the senate with jurisdiction over local government detailing the status of the monuments that mark public land survey corners, the work needed by each county to restore missing or mislocated monuments so that all public land survey corners are documented and marked with monuments, and the estimated costs for each county to complete the work. The report must describe the state's interest in the restoration of missing or mislocated monuments; propose a schedule for state funding, if warranted, for grants to counties to complete the work; whether the county has used or plans to use taxing authority in Minnesota Statutes, section 381.12, subdivision 2, to defray the expenses for the work; identify federal money that may be available for this work; or propose another manner of funding the work.

• Lessons learned

- Can never be too prepared, but don't get stuck preparing
- Build a wide base of supporters
- Understand why your supporters support it, it may be for different reasons than yours

- Talk it up! Sell it early, sell it often, but take off your surveyors hat!
- Stay focused

2023 Legislation

- \$10 Million per year for 4 years
 - More palatable to current congresspeople
- \$1 Million per year for counties to hire technical staff (4 year timeline)
- All other elements remain the same
 - Grant Program for Remonunmentation overseen by Chief Geospatial Information Officer and GAC
 - Work with Surveyors to develop program
 - Prioritize areas of need

Section 1. Minnesota Statutes 2020, section 381.12, subdivision 2, is amended to read: Subd. 2. Expense, tax levy. The county board of any county may levy a tax upon all the taxable property in the county for the purpose of defraying the expense incurred, or to be incurred, less any amount received from the public system monument grant program under section 381.125, for: (1) the preservation and restoration of monuments under this section; (2) the preservation or establishment of control monuments for mapping activities; (3) the modernization of county land records through the use of parcel-based land management systems; or (4) the establishment of geographic (GIS), land (LIS), management (MIS) information systems.

Sec. 2. [381.125] PUBLIC LAND SURVEY SYSTEM MONUMENT GRANT

PROGRAM.

Subdivision 1. Grant program. The chief geospatial information officer, through the Geospatial Advisory Council established under section 16E.30, subdivision 8, shall work with the stakeholders licensed as land surveyors under section 326.02, to develop a process for accepting applications from counties for funding for the perpetuation of monuments established by the United States in the public lands survey to mark public land survey corners, as provided in section 381.12, subdivision 2, clause (1). Grants may also be used to update records and data regarding monuments. The chief geospatial information officer must establish criteria for prioritizing applicants when resources available for grants are not sufficient to award grants to all applicants. The criteria must favor providing grants to counties that demonstrate financial need for assistance.

Subd. 2. Report. By October 1, in each odd-numbered year, the chief information officer must submit a report to the chairs and ranking minority members of the committees in the senate and the house of representatives with jurisdiction over state government and local government. The report must include the following: (1) a summary of the chief information officer activities regarding administration of this grant program for the previous fiscal year, including the amount of money requested and disbursed by county; (2) an assessment of the progress toward completion of necessary monument restoration and certification by county; and (3) a forecast of the amount needed to complete monument recertification in all counties.

Subd. 3. Nonstate match. No nonstate match is required for grants made under this program.

Sec. 3. APPROPRIATION.

(a) \$10,000,000 in fiscal year 2024 is appropriated from the general fund to the chief information officer for the grant program under section 381.125. Up to four percent of this appropriation may be used by the chief geospatial information officer for administration of this program. The base for this appropriation in fiscal years 2025 through 2027 is \$10,000,000. The base for this appropriation in fiscal year 2028 and each fiscal year thereafter is \$0.

(b) \$1,000,000 in fiscal year 2024 is appropriated from the general fund to the chief information officer for grants to counties to employ county technical staff to aid surveyors marking public land survey corners. The base for this appropriation in fiscal years 2025 through 2027 is \$1,000,000. The base for this appropriation in fiscal year 2028 and each fiscal year thereafter is \$0.

About five years ago, M.L.S.A. began work on a Remonumentation Bill to serve the need for preservation and re-establishment of the Public Land Survey. A great deal of work was done by many M.L.S.A. members and supporters and a Remonumentation Bill was ultimately presented to the House and Senate. A reasonable plan for funding was included in the Bill through the State Deed Tax.

Problems encountered along the way were the large sums of money involved in a state-wide program; political science undergraduates on a legislature's staff whose answer to most problems was a two year trial program with a \$5,000 budget; and the education of the legislators as to this Bill and motivating those legislators to implement the Bill.

Let us present the case for the Bill and how it would reduce the costs of future surveys and preserve a resource of the State to the citizens themselves. I propose quarter page ads in the official county newspapers where remonumentation is needed with follow-up information monthly or every other month. Let us show the citizens the problem; how it costs them to have that problem, and what can be done about it. Give them the names and telephone numbers of their County Commissioners and their State Legislators.

Let's build a fire for the citizens of this state and let them apply some heat to their elected officials.
