

MINUTES OF MEETING Minnesota Association of County Surveyors

March 20th, 2012

MACS Meeting @ MnDot Survey Technical Conference.

Lisa Hanni called the meeting to order at 4:30 P.M.

Approval of Minutes: February 16th 2012, Motion Tom Veenker. Second by Lisa Hanni. Approved.

Membership report: 36 voting members, 7 affiliate members

Treasurer's report: \$22,598.15 in treasury of which \$5000 is obligated to the GLO notes scanning project.

Legislative report: No update.

Long Range Planning Committe: General discussion regarding putting on a seminar in October. Jim Hentges to check on possible dates available @ the Kelly Inn in St. Cloud for seminar. Possible topics including Corner Certificate requirements, GLO notes project, Use of GLO Feature calls, Minnesota Lidar project.

SCSU request for support: Robin Mathews updated the group on SCSU's request and provided an email from Eric Fuller detailing specific items needed at the school. Robin also passed around the form to be used for making donations to SCSU. Lisa Hanni made motion to provide funding to SCSU for specific items (AutoCad Civil3D software licenses \$5,000.00, Miscellaneous survey supplies \$1,000.00 and updated TGO processing software \$2,500.00) as provided by Eric Fuller. County Surveyor Map update: Lisa Hanni is working on updating the County Surveyor map and group went through the list and updated to the best of their knowledge.
